- a) The registration fee and the fees are payable strictly in advance. Fees are not refundable or transferable.
- b) Fees payable before the 3rd of every month. Fees paid after the 8th of the month will be charged a 10% penalty, weekly, for every week your fees remain in arrears and your child's lesson will be suspended until payment has been made in full and up to date.
- c) Fees are payable by EFT or you can use your card at the swimming school. **No cash will be accepted**.

- b) NO PARENTS OR OTHER PERSONS are allowed in the pool area during lessons.
- c) Child may not enter the water without the teacher's permission.
- d) Children may not play in dressing rooms.
- e) LESSONS MISSED, CANCELLED OR NOT ATTENDED WILL NOT BE CAUGHT UP OR REFUNDED.
- f) Should your child misbehave and/ or disturbs a lesson he/ she will be given a warning. Should he/ she persist with such behaviour, he/she may be requested to leave the class.

Thank you for contacting us, and welcome to the Bubbles Learn 2 Swim family. Below are a few administrative matters that we would like to make you aware of:

1. GENERAL

- Please note that we love using WhatsApp to communicate!
- You are also welcome to email us: info@bubblesgeorge.co.za
- All lessons have a maximum of 2 swimmers per coach, excluding baby & mom lessons.
- Lessons are twice a week, 20 minutes a lessons (i.e. 40 minutes a week in total)
 - o A swimmer will be in either a Monday & Wednesday slot, or Tuesday & Thursday slot.
- Each term consists of 20 lessons (public holidays are taken into consideration)
- Yes, we do have a transportation service to collect the swimmer from school and drop them off once their lesson is done.

2. RULES

We try to be as accommodating as possible as this is a service being provided, but we kindly as that you take note of the following rules and regulations:

- Please arrive 10 minutes before a class
- No show for a lesson will result in the loss of a lesson.
- Only lessons cancelled by Bubbles Learn 2 Swim will be made up.
- No alcohol or smoking/vaping is allowed on the premises. If you need to smoke, please do so outside the premises.
- All non-swimmers (i.e., parents, grandparents, family, caregivers, friends of the swimmer) are asked to wait in the designated area outside the swimming pool will the swimmer is in a lesson.
 - This is done for a logistical and safety reason.
 - O However, speak to our admin staff should you want to take a photo or video of the swimmer.
- Swimmers are required to wear a swim cap, swimming goggles & appropriate swimwear (no bikinis or Speedos!)
